Checking in

At certain airports where increased security measures have been put into place check-in desks open 3 hours before the scheduled departure of the flight and close promptly 1 hour before – please check the times displayed on your flight confirmation to see if this applies to your selected airport. And remember: if you're late, we won't wait!
